Dear Parents and Sailors:

Welcome to the DC Sail High School Sailing Program! For those who are unfamiliar with DC Sail, our mission is to promote and sustain affordable, educational, recreational and competitive sailing programs for all ages in a fun and safe environment.

Our High School Racing Program is 100% administered by DC Sail, requiring a **\$550** registration fee per sailor, per season. (Need-based scholarships are available.)

Important Weekend Regatta (League) Participation Changes Effective Spring 2022:

Our regional MASSA league has been informed by the national ISSA (Interscholastic Sailing Association) administration that every school represented by sailor(s) must be enrolled with ISSA as an official "team" and be registered in the official "TechScore Platform."

This includes single "Independent" sailors registered for the season, which will result in an additional fee of up to \$150 to cover the ISSA league fees if the sailor wishes to attend weekend regatta competitions and is the sole sailor from their school. Independent sailors registered with the league will be welcome to attend home and away regattas.

Example of additional fees that will be invoiced separately for three or less students from any given school:

One Student	\$150
Two Students	\$75
Three Students	\$50

Full teams are four or more sailors attending from a given school and will sail under their school name. The cost of the league fees will be shared equally by those families. Sailors will attend after-school practices and weekend regattas.

Once registration and the rosters are filled, we will contact parents to advise of what their additional fees will be in order for their sailor(s) to participate in weekend regattas. DC Sail will coordinate the ISSA registrations, and will manage any communications as the primary point of contact.

With that said, we have opted to include a registration level that will allow sailors to attend the after-school practices during the week, but without committing to the league (weekend regatta) participation and additional league fees.

The number of spots available with our program is limited. Be sure to have completed the online registration and issued full payment. To complete the registration process, sailors are required to present the following hard-copy registration documents to coaching staff at tryouts or on the first day of practice.



Deadline for online registration is Thursday, February 17, 2022, as capacity permits. We have sold out to capacity for the last six seasons and suspect this season will be similar. DC Sail will not offer "pro-rated" discounts or refunds once the season has commenced. Sailors are required to be fully committed to complete the season prior to registration. (Late registrations will be considered on a case-by-case basis and based on availability. No discounts are available for late registrations.)

Practice days and the regatta schedule will be emailed to parents/sailors and posted to our webpage once confirmed.

Please carefully review the following COVID-19 Health and Safety Protocols and Policies for the duration where COVID-19 continues to be an issue.

COVID-19 Health and Safety Protocols and Policies

DC Sail is dedicated to the health, safety and wellbeing of our youth sailors and their families. With the guidance of US Sailing, CDC, and local governmental health entities, we have developed strong sanitation and procedural protocols as we reopened our operations and continue to have inforce. All staff are fully trained in these procedures, will be wearing face coverings, and sanitizing equipment, docks, surfaces, and the fleet after each usage.

With concern for the health and safety of your sailor, other students, and our staff, as you prepare for the season and for the duration, we respectfully request that sailors follow the COVID-19 recommendations for wearing face coverings in public where required, wash hands frequently, and please limit time spent in large groups.

Please review the following COVID-19 information carefully for how we will manage our program to assure a safe environment for your sailor:

Life Jackets and Face Coverings:

All attendees are required to wear face coverings while on the docks, which can be removed while on the water if fully vaccinated and/or sailing with a sibling. All sailors will be required to have their own personal life jackets.

Health and Wellness Protocols:

If a sailor is not feeling well or have other members of the household who are ill, they will not be permitted to attend practices or any regatta activities. We will be unable to provide partial refunds for missed days during the season, which has always been our policy and is especially important this year.

Sailors (and Staff) may have noncontact temperature screenings upon arrival. Any sailor not feeling well or with a temperature while at DC Sail will be isolated and sent home as soon as possible.

Any sailor that has positive tested for COVID-19, or has been in close proximity to someone who has the virus, will be unable to attend and only permitted to return after they are fully cleared by a physician and a documented negative COVID-19 test. No refunds will be issued.

In the case of a positive test for COVID-19 or self-quarantine, notification to DC Sail of the sailor's situation should be relayed to DC Sail as soon as it is confirmed.



High School Sailing – Spring 2022 Rules & Regulations

Program Participation Checklist

Sailors:

Like any other JV/Varsity team we use practice time to teach and enhance skills. We expect the following out of our DC Sail sailors. Green Fleet included:

Attitude - demonstrate a positive, cooperative, and sportsmanlike attitude

Boat Skill - demonstrate competence and safety

Attendance – miss no more than 3 practices in the season

Tardiness - tardy no more than 3 practices in a 3-week period (school dismissal time considered)

Attendance

- Sailors will attend each scheduled practice.
- Sailors should arrive on time to each practice.
- A sailor is considered "on time" if he/she is standing on the dock, dressed and ready by 4:00 pm.
- Sailors, and parents, are expected to communicate any anticipated absence.

General Policies

- To ensure safety, sailors must follow the instructions of the coaches at all times.
- Good manners and sportsmanship are always expected.
- Appropriate language must always be used.
- Forms and registration fees must be completed prior to attending practice.
- The coaches make the final determination as to qualification to participate on a daily basis.

On-the-Boat & Docks Policies

- Coast Guard-approved Personal Flotation Device (PFD) must always be worn while rigging and on the water. Sailors will be required to bring their own personal life jacket to practices and regattas.
- Sailors will rig and sail their boats to and from the practice area in an orderly fashion.
- Sailors will return boats and equipment to proper storage areas and alert coaches immediately of any discrepancies or broken equipment.

Diamond Teague Park Piers Policies

• Sailors must speak at an appropriate volume and follow all rules when inside the property of Diamond Teague Park Piers.

Clothing Requirements

- Shoes must always be worn (water boots are best).
- Dry or wet suit w/spray top required when wind + water temperature is less than 120° F.
- Appropriate sailing clothing/gear shall always be worn .

Transportation

- Transportation to and from the practice is the responsibility of the parent / student.
- Transportation for out-of-town events is the responsibility of the parent / student.

Insurance

- Students are covered under NMHF insurance when physically on NMHF property (Diamond Teague Park Piers.)
- Students must be covered by their family insurance policies when traveling and participating in regattas and/or practices not held on NMHF premises.

High School Sailing – Spring 2022 Student Code of Conduct

Please read the following provisions carefully. Both the student and a parent or guardian are required to sign below and return to NMHF.

The primary goal of the National Maritime Heritage Foundation High School Sailing Program is to train young men and women in the basic and advanced skills of sailing, seamanship, and competitive sailboat racing. Safe boat handling skills and good sportsmanship are important aspects of the program. To achieve these goals, NMHF requires all students to follow these rules:

GENERAL SAFETY

- I. A Coast Guard-approved PERSONAL FLOATATION DEVICE (PFD) must always be worn properly secured when in boats and at other times as directed.
- 2. Students should wear clothing appropriate for prevailing weather conditions. Suitable footwear must always be worn . Open-toed footwear is not acceptable.
- 3. No glass containers are allowed anywhere on the grounds of NMHF or in the boats.

BEHAVIOR

- 1. Sportsmanlike conduct is expected of students at all times, on and off the water. Foul language, disruptive behavior, or disrespectful comments or gestures will not be tolerated.
- 2. No running, pushing, or unauthorized swimming is permitted.
- 3. Piers, ramps, and electric hoists are to be used only for their specified purposes.
- 4. Students will return boats and equipment to proper storage areas as soon as possible upon completion of the day's activities. All personal gear and items will be properly secured, and the dock and ramp areas will be kept clean, neat and free from obstructions.
- 5. Student will not tamper with, use or borrow equipment or other items that do not belong to them. Unauthorized use of another's property constitutes theft.
- 6. Students must recognize that we are guests of Diamond Teague Park Piers.
- 7. Use of alcohol, drugs, and other banned substances is strictly forbidden.

ASSUMPTION OF RISK AND RELEASE OF LIABILITY

NOTICE: This release form is a contract with legal consequences. Please read carefully before signing.

Prior to using DC Sail equipment and facilities I hereby freely and voluntarily agree to the following representations, waivers and agreements.

I know and understand that sailing is an activity with a risk of personal injury, property damage and death. I agree that I am responsible for abiding by all of DC Sail's rules and safety precautions including wearing a Personal Flotation Device (PFD) at all times when in the vicinity of the water, both on the dock and the boat. While participating in any DC Sail activity, I agree to operate the program's watercraft in a safe and proper manner and to observe the rules of safe seamanship at all times. I certify that I have no undisclosed physical or medical condition, which, to my knowledge would endanger myself or others while I participate in DC Sail activities. I hereby consent to receive treatment in the event of my injuring, accident, and/or illness during any DC Sail activity.

Being fully aware of the risks, conditions, and hazards associated with sailing, I HEREBY ACKNOWLEDGE that DC SAIL and THE NATIONAL MARITIME HERITAGE FOUNDATION, COASTAL PROPERTIES, and the GOVERNMENT OF THE DISTRICT OF COLUMBIA, their directors, elected officials, officers, employees, founders, members, sponsors, and other organization-affiliated individuals and/or entities are not responsible for injury, illness, death, or damage to personal property. I FURTHER AGREE TO WAIVE, RELEASE AND DISCHARGE for myself, my heirs, executors, administrators, legal representatives, assignees and successors an interest in any and all claims of damages for death, personal injury or property damage which I may have or which may result from my participation in a DC Sail activity. I agree that this is regardless that such injury or damage was the result of negligence or carelessness on the part of the persons or entities mentioned above, and whether such injury or damage was foreseeable or not, including such claims regarding the design, condition of any equipment utilized by me in all activities.

I further agree to forever HOLD HARMLESS and INDEMNIFY all person and entities identified above, specifically from any and all liability for death, personal injury or property damage resulting from my participation in DC Sail activities of any kind.

I give NMHF permission to publish photos, videos and recordings taken of myself during any DC Sail activity. I understand that I will not be paid any royalty or other compensation and I waive any right I may have to payment if a photo, video or recording is published.

I also agree, for myself and my successors, that the above representations are not mere recitals and that they are binding: and that should I or my successors assert any claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending against such a claim unless they are found liable for willful and wanton negligence. This document contains the entire agreement between the parties and if any term of provision of this agreement is found invalid or unenforceable, the remaining terms and provisions of this agreement shall remain biding and enforceable.
